

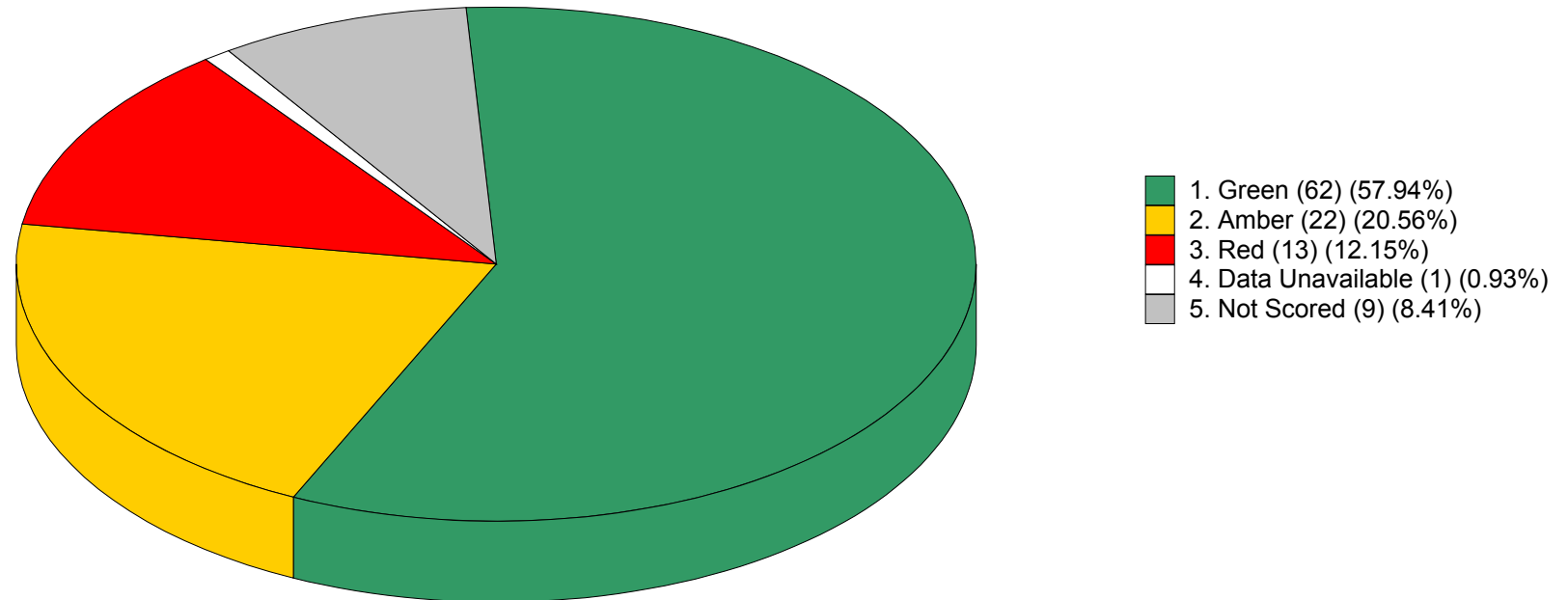

Performance Summary



Red/Amber/Green (RAG) Summary

This chart shows the breakdown of the 107 measures using colour coding to illustrate whether the measure is on target (green), off target (amber) or significantly off target (red). Performance against some measures has not been scored as it is not always appropriate to set targets (for example, where an indicator is measured for information only).

Overall performance across the CYPT Partnership continues to improve. The RAG rating chart above shows more green indicators, approximately the same number of amber indicators and fewer red indicators than when last reported. There are also fewer measures where data is unavailable.

This report underpins the quarterly Performance Improvement Report which includes exception reports on the 8 service areas where performance is persistently flagging as red. This report does not provide commentary on those indicators as they are already discussed in the Performance Improvement Report.
