The audit identified services in the City which sought to protect children and young people from harm and reported on service gaps and needs.
- 16. **RESOLVED** That the audit report be approved in order for it to be distributed to key agencies across the city.

17. CHILDREN'S TRUST PARTNERSHIP STRATEGY

- 17.1 The Board considered a report of the Director Children, Families and Schools that presented a children's services strategy for the next five years which would improve the life changes of all children and young people in Brighton and Hove (see minute book).
- 17.2 **RESOLVED** (1) That the principles and proposed strategy for change be agreed.
- (2) That it is agreed that all future review, redesign, and commissioning of children's services be consistent with the strategy.
- (3) That the Board agrees to a process of public consultation and subsequently to receive a further report setting out an implementation plan, including agreement of key milestones and targets.

18. CHILDREN'S TRUST CONSULTATION FRAMEWORK

- 18.1 The Board considered a report of the Director, Children, Families and Schools that set out the principles and approach of the Children's Trust Partnership to consultation and involvement and the process to ensure that these standards are met and that consultation and participation is properly resourced, planned and co-ordinated (see minute book).
- 18.2 **RESOLVED** (1) That the Children's Trust Partnership commits to the active involvement and participation of staff, service users, the

community and voluntary sector and the public in the planning, development and delivery of services.

- (2) That it is agreed that the approach taken by the Children's Trust Partnership will involve participation at three stages, formative, ongoing and formal.
- (3) That it is agreed that the Youth Council and Parents Forum will be formally consulted to obtain the views of children, young people and parents on the planning and development of services.
- (4) That it is agreed that staff within the Children's Trust Partnership will be involved and consulted through the establishment of a Joint Consultative Forum and the Learning Labs.
- (5) That it is agreed that the Brighton & Hove City Council Public Consultation strategy provides the overarching framework for the Children's Trust Consultation Strategy.
- (6) That it is agreed that there is a formal recognised process for ensuring ethical and appropriate standards of participation and consultation are maintained, and that the consultation proposals will be formally assessed through BHCC Research Governance Team and Clinical Effectiveness and co-ordinated through the Communication and Consultation Team.

19. CONSULTATION ON THE CORE PROGRAMME AND CHILDREN'S CENTRES

- 19.1 The Board considered a report of the Director Children, Families and Schools that presented proposals for consultation with staff and the public on the Children's Trust Partnership Strategy, Core Programme and Children's Centres (see minute book)
- 19.2 **RESOLVED** (1) That the Board agree the draft service specification (Appendix 1) and public consultation document (Appendix 2) for the core programme and children's centres as the basis for consultation on services for this age group prebirth to age 4.

20. BRIGHTON & HOVE CHILDREN'S FUND DELIVERY PLAN

- 20.1 The Board considered a report of the Director Children, Families and Schools that sought consideration and approval for the delivery plan for the Children's Fund in Brighton and Hove from 2005-8 (see minute book)
