Subject: Suspension or Revocation of Driver Licences under

the Road Safety Act 2006

#### 1. Purpose of the report

That committee adopt the policy contained in 2.2 below with regard to the immediate suspension or immediate revocation of hackney carriage or private hire driver licences.

#### 2. Recommendations

- 2.1 That Committee adopt the following policy with regard to the immediate suspension or immediate revocation of hackney carriage or private hire driver licences.
- 2.2 The Council in determining its powers of immediate suspension or immediate revocation, will consider each case according to its merits and where it is satisfied that in the interests of public safety require such a course of action; an offence is committed of such a serious nature as to warrant such action; a medical condition exists that makes it unsafe to continue working the decision will normally be to suspend or revoke with immediate effect.

#### 3. Information/Background

From 16 March 2007 the Road Safety Act 2006 gives Local Authorities the power (discretion) to suspend or revoke hackney carriage and private hire driver licences with immediate effect, where it is of the opinion that the interests of public safety require such a course of action.

The Department of Transport has not issued any guidance on the use of this new power.

Previously all drivers that had their licence suspended or revoked were able to continue to drive for 21days following suspension or revocation. If during the course of the 21 days the driver made application to appeal the council's decision to suspend or revoke they could continue to drive until the appeal was determined by the magistrates.

## **Legal Implications**

Prior to the coming into force of section 52 of the Road Safety Act 2006 on 16 March 2007, a hackney carriage (HC) or private hire (PH) driver whose licence had been suspended or revoked had a legal right to continue working as a HC or PH driver until the 21 day period for appealing to the Magistrates' Court had expired or, where an appeal had been lodged, until the appeal had been determined. The Council now has the power to suspend or revoke a driver licence with immediate effect where it is of the opinion that the interests of public safety require such a course of action. The immediate suspension or revocation only takes effect when the decision notice is given to the driver.
