Fairness

- 1 SEND inherently unfair
- 1 Is it fair that SEND gets only this slot?
- Is it fair that SEND is often not on the 'agenda' for a whole range of meetings?
- Is it fair that I get 10 minutes to discuss an issue that has been my professional passion since 1979 & a personal necessity since 1962?
- 1 That said... what are our SEND fairness issues?
- 1 Difficult to divorce local from national context

Access & Equality

- 1 19-25 year olds, but no additional money
- 1 19+ in Brighton & Hove
 - Equity

- Life long learning
- Impact on adulthood & ongoing wellbeing
- Potential even for the most profoundly disabled
- Community services segregation in an inclusive city but loss of clubs (eg BHIP).
- 1 Inclusion & access to peers

Access & Equality - 2

- Learning Difficulties vs SEMH criteria for respite
- 1 Cut to short break money & direct payments as more families join system
- 1 The new integrated provisions but what about SEND children included in mainstream schools?

Access & Equality - 3

- Areas but also pockets of socio-economic deprivation – support focused in areas not pockets (eg pre school)
- 1 Travel difficulties & cost
- Benefits changes harder & harsher re SEND. New Personal Independence Payments (PIP) vs DLA
- 1 44% of parent carers of children with SEND are in single parent households

Unemployment & Employability

- Employment consultation last Tuesday SEND not mentioned once
- Learning Partnership then Learning Employment & Skills Partnership
 - SEND rarely features
 - what employers want vs what our community needs

Unemployment & Employability - 2

- 1 Issue of apprenticeships L2
- Loss of L1 courses in colleges, loss of NACRO
- Job coaching city is an employer (eg HTH opportunity)
- 1 'Able & Willing' Knoll Business Park
- NEET data 42% @ 20+ (self identifying as having a learning difficulty) – we have employable students

Early Years & Early Intervention

- Importance of early intervention life long impact
- 1 Cuts EY consultants & Specialist EY Educational Psychologist
- 1 Change to EPS/LSS PRESENS
- 1 Loss of children's centres?
- Need to travel to cheaper (charitable) settings out of neighbourhood.
 - Compounded by poorer resourcing there

The 'System'

- Incompatible agendas floor standards & inclusion
- What is valued but unachievable GCSE standard but no jobs
 - 16-19 yr unemployment is 45%, (national 25%)
- 1 Inter-generational unemployment

The 'System' - 2

- Access to services & transport issues eligibility criteria, buses
- Awareness of services reduction of support & advice (eg Amaze).
- 1 SENDIST; socio-economic issue, families that are able to fight
- 1 'real education' SEND leisure time, volunteering

Recommendations

- Positive discrimination by employers
 - Employers with a social conscience
 - Getting employers in (BACA)
- 1 19+ for all
- 1 Tackle NEET issue
 - College courses & pastoral support
 - Better internship programmes/job coaching for non level 2 learners
 - Better transition support; aligned child/adult services

Recommendations - 2

- SEND proposals resource / implement extended/waking day, family support – but remember mainstream children & inclusion
- 1 'Spend to save'
 - SEND world is a fragile & costly world
 - Value of systems, including voluntary sector, who can attract charitable funding & draw funds in (increase benefit take up)

Recommendations - 3

- 1 SEND being on the agenda *always* in future
 - Not an afterthought
 - Not marginalised or isolated
 - "No one left behind"
