Deputation concerning the late night disturbance in Surrey Street, Brighton Spokesperson – Charlotte Glasson

Since the Station Gateway development our street has become an unofficial taxi rank, as taxis queue to pick up passengers off the trains. The neighbourhood has really suffered from the taxi drivers' anti-social behaviour, especially at rush hour and throughout the evening through to 2.30am when the last train comes back from London.

Residents can't sleep due to engines left running, radio blaring out of their cabs, swearing, hooting of horns as traffic is unable to pass. When asked to move on by residents they are often threatening, even on one occasion shouting racial remarks to a young mother, and intimidatory, leaving us feeling unsafe.

Residents have also stepped in to break up fights late at night between taxi drivers as they fight over spaces.

There a quite a few children living in the street. Other residents have been signed off work due to depression and stress due to lack of sleep etc.

We would like to see greater policing of the area, we would like a CPO to help manage the situation and hope a solution can be found as we have been suffering for 3 years and it seems to be getting worse.

FAIRNESS COMMISSION RECOMMENDATION BDA CHARTER FOR BRITISH SIGN LANGUAGE

CLARIFICATION TO THE REPORT

Officer technical amendment to the report:

The Chair of the Neighbourhoods, Communities & Equalities Committee will note that there is an officer's technical clarification to the report's recommendation 2.1 and financial implications paragraph wording in paragraph 8.1. This requires the deletion of first recommendation 2.1 and its replacement of a new recommendation and the deletion of paragraph 8.1 and its replacement with a new paragraph 8.1 as detailed below.

The resultant changes follow additional information received from the British Deaf Association (BDA), whereby the BSL Charter has changed in the following ways:

- that the pledges have been re-jigged and are now listed in a different order
- that there are more detailed objectives and benefits;
- the process has been changed to include the signing of a working partnership agreement and
- a scale of, optional, costs has been introduced

The BDA states that the changes are a result of it seeking to be more inclusive in securing local and national services across the UK to sign up to the BSL Charter.

It is therefore proposed to:

Delete the following:

Recommendation

2.1 That Committee, on behalf of the council, sign up to the BSL Charter and work with the British Deaf Association and local Deaf and BSL groups towards fulfilling the requirements of one or more of the pledges under the charter as set out below;

Financial Implications

8.1 There are no immediate financial implications arising from signing the BSL Charter. Any resource implications identified during the self-assessment and three year planning stage will be reported to relevant committee for decision. Liaising with the BDA, completing the self-assessment and developing the action plan will be delivered within the resources of the Communities, Equalities and Third Sector (CETS) service.

NC&E 13/03/17 Technical amendment 01

Revised Recommendation 2.1 and paragraph 8.1 to read:

- 2.1 "That committee agrees that the council will sign up to pledges 2, 3 and 5 as outlined in appendix 1 of the committee report;"
- 8.1 "As a result of new information provided by the BDA week commencing 6th March 2017 there are immediate financial implications arising from signing the charter. These are in regard to the signing ceremony and the development of the action plan; estimated to be £350 for 2017/18, £1,100 for 2018/19 and £300 for 2019/20 based on the pricing structure provide by the BDA. These costs will need to be met from the Communities, Equality and Third Sector team budget. Should further work with the BDA and the Working Partnership Agreement have financial implications over and above those manageable with existing budget a report will be brought back to this committee and PRG committee if required."

Additional information:

As a result of the introduction of a scale of optional costs by the BDA the Communities, Equality and Third Sector team has estimated the expenditure that would be required over the next 3 years of working towards the pledges. This is shown in the table below and takes into account resources within the council and also the commission of deaf engagement work through the council's communities and third sector commission 2017-2020.

Deaf people in Britain campaigned for many years for the recognition of BSL considering this to be a human rights issue.

This campaign was for the right to positively identify with one's language(s), and for others to respect this identification. It asked for BSL to be recognised as a native indigenous language and for Deaf people to have the right to learn it, to develop in formal school settings by being taught through it and to have the right to use it in official contexts (schools, hospitals, police services, naming of children, religion). On 18th March 2003, the British Government recognised BSL as a language in its own right and as an indigenous language used in the UK.
