The scheme shall be carried out in full as approved prior to first occupation of the development and the refuse and recycling storage facilities shall thereafter be retained for use at all times. No refuse and recycling collections shall take place on the site except between the hours of 07.00 and 19.00 on Monday to Sunday.</p> <p>Reason: To safeguard the amenities of the occupiers of adjoining properties and to comply with policies SU10 and QD27 of the Brighton &amp; Hove Local Plan.</p> <p><b>Additional Conditions:</b></p> <p>28. The hard surfaces hereby approved shall be made of porous materials and retained thereafter or provision shall be made and retained thereafter to direct run-off water from the hard surface to a permeable or porous area or surface within the curtilage of the property.</p>

Prior to first occupation of the development hereby permitted, a scheme for landscaping shall have been submitted to and approved in writing by the Local Planning Authority. The scheme shall include the following:</p> <p>a) Details of all hard and soft surfacing;</p> <p>b) Details of all boundary treatments;</p> <p>c) Details of all proposed planting to all communal areas and/or all areas fronting a street or public area, including numbers and species of plant, and details of size and planting method of any trees.</p> <p>All hard landscaping and means of enclosure shall be completed in accordance with the approved scheme prior to first occupation of the development. Having now had conversations with both Wayne Nee and Caroline Lucas's office, I understand that the sticking point, ie noise nuisance to nearby residents, has now been addressed by Hyde Housing having fulfilled their obligations in this regard by dealing with noise ingress through air vents, and installing triple glazing to windows overlooking the courtyard. Caroline Lucas's office has confirmed that they have not received any noise complaints for some considerable time. I also understand from a meeting some months ago with Mr de Souza from The Druids Arms, that the courtyard is closed at a reasonable time.

I am therefore writing to confirm that a) I do not wish to speak at Committee, and b) for the reasons stated above, I wish to withdraw my objection.
