Note: The special circumstances for non-compliance with Council Procedure Rule 3, Access to Information Procedure Rule 5 and Section 100B(4) of the Local Government Act 1972 (as amended), (items not considered unless the agenda is open to inspection at least five days in advance of the meeting) were that the public consultation closed on 19 November 2017, scheduled meetings with the Cross Party School Organisation Working Group regarding the school admission arrangements concluded on 20 December 2017 and a late submission was received from Varndean School on 5 January.

#### 1. PURPOSE OF REPORT AND POLICY CONTEXT

- 1.1 The City Council is the admission authority for maintained community schools in the city. The admission arrangements for schools must be determined 18 months in advance of the academic year in which they will take effect. This report outlines the responses to the published consultation undertaken between the 2 October 2017 and 19 November 2017 and makes recommendations to the Committee of proposals to take forward in light of those responses and revised data regarding the expected number of pupils in the city requiring a school place.
- 1.2 Local Authorities set out the Published Admission Number and catchment areas as well as schemes for co-ordinated admissions, including key dates in the admission process, and the arrangements for consultation with own admission authority schools in the city and with other Local Authorities. They also establish the area (the "relevant area") within which the admission consultation should take place.
- 1.3 The City Council must have confirmed its admission arrangements for 2019-20 by 28 February 2018 in order to conform to the requirements of the School Admissions Code.

#### 2. **RECOMMENDATIONS:**

2.1 The committee agree to reduce the Published Admission Number at Moulsecoomb Primary School by 30 pupils in September 2019 (Paragraph 3.15).

- 2.2 The committee agree to reduce the Published Admission Number at Coombe Road Primary School by 30 pupils in September 2019 (Paragraph 3.16).
- 2.3 The committee agree to reduce the Published Admission Number at West Hove Infant School (Connaught Road site) by 30 pupils in September 2019 (Paragraphs 3.17 3.18).
- 2.4 The committee agree to make no change to the Published Admission Number at Benfield Primary School in September 2019 (Paragraphs 3.19 3.20).
- 2.5 The committee agree to make no change to the Published Admission Number at Hertford Infant School in September 2019 (Paragraphs 3.21 3.22).
- 2.6 The committee note the permanent increase to the Published Admission Number of Blatchington Mill School and Sixth Form from 300 pupils to 330 pupils with effect from September 2018 (Paragraphs 3.34 3.35).
- 2.7 The committee agree to the permanent increase to the Published Admission Number of Patcham High School from 215 pupils to 225 pupils in September 2019 (Paragraph 3.31).
- 2.8 The committee agree to an additional temporary class of 30 pupils at Dorothy Stringer High School for admission in September 2019 and again in September 2020 (Paragraphs 3.32).
- 2.9 The committee agree to an additional temporary class of 30 pupils at Varndean School for admission in September 2019 and again in September 2020 (Paragraphs 3.32).
- 2.10 The committee agree to note the request to permanently increase the Published Admission Number of Varndean School which will be subject to further discussions between the governing body and the Council (Paragraph 3.33).
- 2.11 The committee agree to make no change to secondary school catchment areas (Paragraph 3.48) shown in Appendix 8.
- 2.12 The committee agree that the proposed school Published Admission Numbers set out in Appendix 6 be adopted for the admissions year 2019-20 (Paragraphs 3.61-3.62).
- 2.13 The committee agree that the admission priorities for community schools set out in Appendix 7 be adopted for the relevant age groups (Paragraphs 3.55 3.59).
- 2.14 The committee agree that the co-ordinated schemes of admission for the admission year 2019-20 (Paragraph 3.63 and Appendices 9 and 10) and relevant area (Paragraph 3.60) be approved.

#### 3. CONTEXT/ BACKGROUND INFORMATION

3.1 The Children Young People & Skills (CYP&S) Committee on 18 September 2017 recommended that a public consultation was undertaken on proposed changes to the council's admission arrangements including changes to secondary school

- catchment areas and the reduction in Published Admission Number (PAN) of five primary schools.
- 3.2 A 7 week consultation period ran from 2 October 2017 19 November 2017. During that time 13 public meetings were held, attended by approximately 310 people, the online consultation form received 907 responses and 48 emails were received into the specific consultation mailbox. Three petitions have been received either at Full Council or CYP&S committee, alongside three deputations.
- 3.3 A summary of all the responses received via the Council's Have Your Say online consultation portal can be found in Appendix 2. Due to the nature of the consultation covering various proposals it is worth noting that respondents may have commented on only part of the overall consultation and not all aspects of the proposals.
- 3.4 During the consultation period a commitment was given to review the data used to inform the proposals brought forward. Projections of future pupil numbers in each of the secondary school catchment areas had been modelled using the School Census data from October 2016 and projections of primary pupil numbers generated using GP registration data which had been received in November 2016. The timing of the consultation, determined by statutory guidance, the School Admissions Code, meant that data from the October 2017 census and from the NHS was not available for analysis prior to consultation.
- 3.5 The Cross Party School Organisation Working Group (CPSOWG) has met twice since the consultation closed to consider the responses received. These meetings took place on 27 November 2017 and 20 December 2017. The Secondary Admission Working Party (SAWP) met on 6 December 2017.

#### **Changes to Pupil Projection Data**

3.6 There has been a reduction in the number of primary aged pupils recorded as living in the city and being registered with GPs, as compared with the data supplied in November 2016, as detailed in Table 1.

3.7 A total of 222 fewer primary aged pupils are recorded as living in the city and registered with a GP surgery.

3.8 The prediction of future primary school pupil numbers has also been adjusted to take account of updated GP registration data and is fully detailed in Appendix 3. There are anticipated to be 43 fewer pupils starting school in September 2019. In total 2,597 places are expected to be required.

- 3.9 The updated GP registration data indicates that the future number of secondary aged pupils will reduce because of the reduction in the number of children living in the city, registered with GPs, between October 2016 and October 2017.
- 3.10 There has been a fall in the number of pupils recorded on roll at the city's schools as shown in the School Census data taken in October 2016 and October 2017. Comparing all year groups that feature in both census returns there is a reduction of 341 pupils attending the city's schools. The largest reduction (163 pupils) occurred in the cohort who started Year 7 in September 2017.
- 3.11 It is not the purpose of this report to speculate on the reason for the reduction that has happened in the last 12 months. However when this base data is applied to the calculations used to predict the demand for future secondary school places it has brought about a small reduction in the anticipated number of pupils requiring a school place.
- 3.12 Using the most recent census data has generated a reduction in the total number of pupils requiring a place in a catchment area school of 52 pupils in 2019 and 87 pupils in 2020. A summary is provided in Table 3 and Table 4 below.


- 3.13 Under the existing catchment area model, the Dorothy Stringer and Varndean schools catchment area was identified as having more pupils than places available. The revised data has reduced the shortfall of places by 27 places in 2019 and 43 places in 2020. There still remain more pupils than places available in the catchment area in the two years under consideration, a shortfall of 69 places in 2019 and 93 places in 2020.
- 3.14 Even with the additional places offered by both schools on a temporary basis not all pupils living in the catchment area can be offered a place at one of the catchment area schools. However the number of pupils who will not receive a place is fewer than that indicated by the projections calculated using the October 2016 census data and there are sufficient places overall in the city for all pupils who require a place.

#### **Primary School Published Admission Numbers**

#### **Moulsecoomb Primary School**

3.15 The summary of responses received is shown in Table 5 below. In total 44.3% of all respondents tended to or strongly agreed with the proposal. Comments received reflected on low pupil numbers in the area as a result of changes in housing use. As outlined in the September 2017 committee report, the proposal to reduce the school's PAN by 30 pupils from three forms of entry to two forms of entry is supported by the school's governing body, although they are clear that any additional reduction in the school's PAN would not be supported. It is therefore recommended that the school's PAN is reduced.



#### **Coombe Road Primary School**

3.16 The summary of responses received is shown in Table 6 below. In total 43.7% of all respondents tended to or strongly agreed with the proposal. Comments received reflected on low pupil numbers in the area as a result of changes in housing use and a concern about there being sufficient school places locally should a reduction in PAN take place at Hertford Infants, Coombe Road and Moulsecoomb primary schools. As outlined in the September 2017 committee report, the proposal to reduce the school's PAN by 30 pupils from two forms of entry to one form of entry is supported by the school's governing body. It is therefore recommended that the school's PAN is reduced.



#### **West Hove Infants (Connaught Road)**

- 3.17 The summary of responses received is shown in Table 7. In total 40.6% of all respondents tended to or strongly agreed with the proposal. Comments received related to concern about recent decisions on future housing being made in the proximity, concern about the current size of the school and the impact other historical school expansions had on the availability of places in the area. Some concern was also expressed that the proposal would reduce the possibility that families living in the south western areas of Hove would be denied an opportunity to attend a local school, especially with the corresponding proposal to reduce the PAN of Benfield Primary School.
- 3.18 As outlined in the September 2017 report, the proposal to reduce the school's PAN by 30 pupils from four forms of entry to three forms of entry was supported by the school's governing body. Whilst concerns have been expressed as outlined above it is recommended that the school's PAN is reduced.




#### **Benfield Primary School**

3.19 The summary of responses received is shown in Table 8. In total just 26% of all respondents tended to or strongly agreed with the proposal. Only 18% of respondents who are governors in a Brighton and Hove school tended to or strongly agreed with the proposal. Many comments were received regarding the journey that the school has been on leading to it recently gaining Teaching School status and its contribution to the city's wider school improvement work. It was felt by many respondents that this would be put at risk should the school's PAN be reduced to one form of entry. Concerns were also expressed about the school being able to admit all pupils who wish to attend the school and the options available to parents who would not wish to send their child to a one form entry primary school, if the PAN was reduced.

3.20 The school's governing body do not support the proposal and after considering the range of responses it is recommended not to propose the reduction in PAN from two forms of entry to one form of entry.



#### **Hertford Infant School**

- 3.21 The summary of responses received is shown in Table 9. In total just 13.4% of all respondents tended to or strongly agreed with the proposal. Only 11% of respondents who are governors in a Brighton and Hove school tended to or strongly agreed with the proposal. Many comments were received regarding the impact of reducing the infant school to one form of entry including the school's financial viability, the effect on the surrounding area and the demographic of the school. Many respondents commented on the quality of the current provision of education available at the infant school and the junior school, including their impact in reducing the gap in performance between disadvantaged pupils and non-disadvantaged pupils as well as considering the impact on other schools in the neighbouring area.
- 3.22 The school's governing body do not support the proposal and after considering the range of responses it is recommended not to propose the reduction in PAN from two forms of entry to one form of entry.

- 3.23 Currently there are 3,030 primary school places available in the city. Should the recommendations be agreed, 90 primary school places will be removed in September 2019 leaving 2,940 primary school places. The Council remains concerned that the number of available places in primary schools across the city exceeds the number of pupils projected to require a place in the foreseeable future by over 300 places, just over 10% surplus capacity.
- 3.24 With lower pupil projection numbers, a reduction of 90 places in September 2019 does not sufficiently address the issue and with continued pressure on school budgets there may be a need to review PANs or look at other organisational changes in future years.
- 3.25 Appendix 3 shows that in the following primary school planning areas there remain significant surplus places:
  - Portslade
  - Hangleton and Hove Park
  - West Blatchington and North Hangleton
  - Hollingbury and Preston Park to Seafront
  - The Deans

and the council will need to work with governing bodies and Headteachers to ensure there is no detrimental effect on the performance of schools.

#### **Secondary School Admission Arrangements**

3.26 The Council put forward a proposal to undertake a light touch review of secondary school catchment areas and recommended that this change was for a two year period (2019 and 2020). The council recognised that some respondents to the consultation did not agree with the description of the proposed changes as light touch, a term used to distinguish these proposals from the more wide ranging proposals put forward in the engagement activity in Spring 2016.

- 3.27 In order to alleviate the issue of catchment areas failing to catch the council proposed a review of catchment areas. This was put forward to look to reduce the uncertainties experienced by some parents as in recent years the number of pupils in some catchment areas had exceeded the places available at the catchment school(s). The intention was that the proposed changes would better match the number of pupils living in a catchment area with the places available at the relevant catchment school(s).
- 3.28 The committee report in September 2017 outlined that the projections showed that in 2019 there would be 2,598 pupils requiring secondary school places. In 2020 there would be 2,590 pupils requiring secondary school places. In 2019, the BACA, Blatchington Mill/Hove Park and the Dorothy Stringer/Varndean catchment areas were projected to have more pupils than places available. In total it was forecast that 126 pupils would not be able to be accommodated in their catchment area school in September 2019. In total it was forecast that there were 100 places in the Patcham High School, Longhill High School and Portslade Aldridge Community Academy (PACA) catchment areas that would not be filled from children living in the catchment area in September 2019. In 2020, it was forecast that 138 pupils would not be accommodated in their catchment area and, in total, 120 places in the BACA, Patcham High School, Longhill High School and PACA would not be filled by catchment children.
- 3.29 As has been noted in paragraphs 3.6 3.14, the latest GP data and school census data shows a reduction in numbers of school age pupils. This is the data on which the forecast of pupil numbers are based and consequently this has brought about a reduction in the anticipated number of pupils requiring a school place in future years.
- 3.30 During the consultation it became evident that some existing schools wished to provide additional places by increasing their PAN.
- 3.31 Patcham High School has requested to increase their PAN permanently by 10 pupils from 215 pupils to 225 pupils from September 2019. The request from the governing body is to ensure that the school has the appropriate number of children in the school to more accurately reflect the school's capacity. The school states that the number of children it has in Key Stage 4 is not sufficient to fill all the subjects that the school would like to be able to offer in order to provide a wide and varied curriculum.
- 3.32 A joint response to the consultation from the governing bodies of Dorothy Stringer and Varndean Schools states that they would now be prepared to admit an additional form of entry, as a temporary measure, in both September 2019 and September 2020. Both schools had felt unable to admit additional pupils in September 2017 due to concerns about increasing pressures on teaching accommodation and other common areas in the school such as toilets, corridors and dining areas. They had also expressed concerns about the amount of space available to support pupils with additional needs. However notwithstanding these issues both schools have advised that offering additional temporary forms of entry for 2019 and 2020 will in their view provide greater clarity and stability to families in their current catchment area.

- 3.33 In a late submission from the governing body of Varndean School, they have made a request to increase their PAN from 270 to 300 pupils on a permanent basis from September 2018. No recommendation is made in this report, regarding the request, on account of the time available to fully understand impact of this proposal including the future capital funding implications.
- 3.34 Blatchington Mill School indicated a willingness to permanently admit an additional form of entry. Whilst the school publicly indicated their willingness to do so during the period of the public consultation the school had also sought to appeal to the Office of the Schools Adjudicator to appeal against the PAN set for the school in September 2018.
- 3.35 The Schools Adjudicator determined their appeal on 19 December 2017 and has confirmed that the school's PAN has increased for September 2018 to 330 pupils. As a result of this determination the Council agrees that the school's PAN in September 2019 will remain at the higher level of 330 pupils.
- 3.36 With the additional places available at Blatchington Mill school the total number of school places within the city's catchment areas is 2,135. If the Council agrees to provide additional temporary places at Dorothy Stringer and Varndean schools, then this, together with the small increase in PAN at Patcham High School, means that, there will be a total of 2,205 school places in the city's catchment areas.
- 3.37 The modelling of future pupil numbers revised with the data from the October Census 2017 information (Appendix 4) indicates that using the current catchment area model the total number of places required in the city's catchment areas is 2,079 in September 2019 and 2,036 in September 2020. Across the city in total there are projected to be 2,506 pupils requiring a school place in September 2019 and 2,463 in September 2020.
- 3.38 As summarised in Tables 3 and 4 and paragraph 3.12 above the most recent census data shows a reduction in the total number of pupils requiring a place in a catchment area school of 52 pupils in 2019 and 87 pupils in 2020.
- 3.39 As detailed in paragraphs 3.13 and 3.14, the latest data has reduced the shortfall of places in the Dorothy Stringer and Varndean schools catchment area by 27 places in 2019 and 43 places in 2020. There still remain more pupils than places available in the catchment area in the two years under consideration, a shortfall of 69 places in 2019 and 93 places in 2020. Even with the additional places offered by both schools on a temporary basis not all pupils living in the catchment area will be able to receive a place at one of the catchment area schools.
- 3.40 The number of pupils who will not receive a place is fewer than that indicated by the projections calculated using the October 2016 census data and there are sufficient places in the city for all pupils who require a place.
- 3.41 Beyond the two year period that the changes to catchment areas were being proposed to consider, it can be seen in Table 10 that the number of pupils requiring a place in 2021 and 2022 has also reduced. Whilst there remain insufficient places in the catchment areas for all pupils expected to require a

place, (in 2021, 2,171 pupils for 2,135 places), it now appears as though there are sufficient places across the city with 2,598 pupils and 2,645 places in 2020 and 2,537 pupils for 2,645 places in 2021.



- 3.42 Therefore with an additional 100 places available in the city's catchment area schools in 2019 and 2020 and the estimated number of pupils in the city requiring a school place falling by 92 pupils in 2019 and 127 pupils in 2020 careful consideration has been given to the proposal to make changes to the secondary school catchment areas.
- 3.43 The data modelling the demand for places in catchment areas does not take account of the number of additional pupils who will be requiring a school place in the city as a result of house building (Appendix 5). As previously referenced in the September 2017 committee report the City Plan states that an additional 13,200 homes will be built in the city by 2030 and it is anticipated that this will generate an additional 1,216 primary aged pupils and 1,046 secondary aged pupils.
- 3.44 The Council is cautious to avoid underestimating the impact the potential increase in pupil numbers caused by new homes being built will have. However it does recognise that in the immediate future many of these new homes will not be completed in the timescale first estimated. Therefore in considering the recommendations in this report more emphasis has been placed on the catchment area forecasts than the additional children expected as a result of house building.
- 3.45 Whilst pupil forecasting is not an exact science, the Council is confident that its methodology used to predict pupil numbers is accurate. When estimating the need for places in September 2018 the Council calculated there would be 2,520 places required and the Council has received 2,527 applications. It is the change in source data that has generated revised pupil numbers.
- 3.46 As Table 11 below indicates, the overall response to the consultation on secondary school catchment areas was not supportive of the proposal to make changes. Just 18.8% of respondents tended to or strongly supported the proposals. More than 90% of all those who responded and who lived in the four affected areas tended to or strongly disagreed. A similar number of respondents (174 in total), living in the Varndean and Dorothy Stringer schools catchment area (but not in the affected area), agreed with the proposals as disagreed with the proposals. Themes that emerged through the consultation in relation to the proposals included:
  - The splitting of communities

- Pupils unable to attend secondary school with friends made in primary school
- Additional distance to travel to schools
- A temporary change now and more change to follow causing uncertainty
- Explore the additional places offered by the existing schools
- Proposals did not offer choice with some catchment areas only having one school in it

- 3.47 This is not a complete list and many respondents raised specific issues about how the proposed changes affected them directly.
- 3.48 With the majority of respondents opposed to the changes being proposed, together with the change in pupil forecasts indicating a reduction in the number of pupils requiring a school place and the willingness of some schools to provide additional places it is recommended that no change is made to the existing secondary school catchment areas.
- 3.49 It is proposed that Patcham High School increase their PAN permanently by 10 pupils to 225 pupils and both Dorothy Stringer and Varndean schools admit an additional 30 pupils into Year 7 on a temporary basis in 2019 and 2020.

- 3.50 No change to catchment areas and the provision of an additional 100 places in 2019 still means that not all pupils living in catchment areas will receive a place in their catchment school(s).
- 3.51 Whilst recognising there are views and opinions recorded in the consultation that supported the proposed change to catchment areas, the Council has taken careful consideration of the range and strength of feeling within communities. In making no change to catchment areas the Council will still be able to ensure it meets its statutory duty to ensure sufficient school places for all pupils who require one. However this does not constitute a guarantee that a child will be offered a place at its catchment area school(s).
- 3.52 The Council is also mindful that as a result of making no change to catchment areas there will continue to be some catchment areas where there are fewer pupils than places available. Specifically the catchment areas of Longhill High School and both the Brighton Aldridge Community Academy and the Portslade Aldridge Community Academy.
- 3.53 Encouragingly, during the consultation many positive comments were made regarding the provision of education available at these schools and across the city.
- 3.54 The proposed changes to the catchment areas would have brought an overall reduction in the number of surplus places in the catchment areas but would not have eliminated this matter entirely. The Council will continue to support these schools to ensure that whilst they manage the impact of surplus places there is no deterioration in standards of education.

## The oversubscription priorities for community secondary schools, BACA and PACA

- 3.55 Responses to the consultation on the oversubscription priority of secondary schools broadly raised points regarding the need and relevance of a sibling link, the implementation of the category two priority relating to compelling medical or other exceptional reasons and the definition of children who were previously in the care of a local authority but have ceased to be so.
- 3.56 It had been proposed to create a sibling link priority should there have been changes to catchment areas. As this report is not recommending a change to catchment areas it is proposed not to change the current admission priorities.
- 3.57 The Council has noted a recent letter sent to all local authorities and admission authorities from Rt Hon Nick Gibb MP, Minister of State for School Standards dated 4 December 2017 in which he encourages admission authorities, when setting admission arrangements, to use their discretion and give the highest priority for admission into school children who were previously in care outside of England. Admission authorities that have already started consulting are encouraged to introduce the change in future years.
- 3.58 The council is sympathetic to the intention to recognise the vulnerability of these children and the intention to place their situation on an equal footing for the purposes of admission to school and notes the wording of the council's

admission priorities does not preclude consideration of those children previously in care outside of England.

## The oversubscription priorities for community infant, junior and primary schools and City Academy Whitehawk

3.59 Fewer than 50 responses were received in relation to the oversubscription priority for primary schools. Similar responses to those outlined in paragraph 3.55 were made. It is recommended not to change the admission priorities from those currently established.

#### The 'relevant area' for consultation

3.60 Fewer than 60 responses were received regarding this element of the consultation. The majority of the responses were not specifically related to the 'relevant area' which is the area which the Local Authority uses when consulting on admissions arrangements. It is currently defined as the area within the Brighton and Hove city boundaries and no change was proposed to the relevant area for September 2019. It is recommended that no change is made to the 'relevant area as currently stated.

## The Published Admission Numbers of all other community schools, BACA, PACA and City Academy Whitehawk

- 3.61 Fewer than 70 responses were received to this element of the consultation. Some specific suggestions were made and there were a number of responses relating to reducing the PAN in the bigger primary schools thereby allowing other schools to have a "fairer share" of the children.
- 3.62 No other governing body submitted a request to reduce their PAN and therefore it is recommended to make no further adjustments to PANs other than those referred to earlier in this report.

#### The co-ordinated admission schemes for 2019/20

3.63 Fewer than 40 responses were received regarding this matter. The majority of responses were not specifically relevant to the schemes and where individual points were made regarding the co-ordinated scheme these do not indicate a need to amend the proposals and therefore it is recommended that no change is made to these schemes.

#### 4. ANALYSIS & CONSIDERATION OF ANY ALTERNATIVE OPTIONS

4.1 The Council proposed to make changes to the PAN of five primary schools and the secondary school catchment areas. This report recommends that as a result of the responses received to the consultation no change is made to the PAN of Benfield Primary School and Hertford Infant School and there is no change to secondary school catchment areas. Accordingly it is proposed to adopt the admission arrangements as set out in appendix 7. These arrangements are unchanged to those adopted in 2018/19, with the exception of the revised PANs for those schools set out in recommendations 2.1-2.3, 2.6 and 2.7 of this report.

- 4.2 The council has carefully considered the responses received and has determined that it would not be appropriate to continue with all the proposals as originally set out.
- 4.3 The council believes that with the support of the governing bodies to reduce the PAN of three primary schools the reduction remains an appropriate decision to make. This is supported by the revised projections which indicate that there will be a large number of surplus primary school places in the foreseeable future.
- 4.4 The revision of pupil number forecasts generated by the revised October School Census data, coupled with the revised GP registration data indicates that pupils have left the city in the last 12 months. This had not been anticipated and does not support the continuation of proposals to change secondary school catchment areas when consideration is given to the opportunity to provide additional places in some of the city's secondary schools.

#### 5. COMMUNITY ENGAGEMENT & CONSULTATION

- 5.1 Following recommendation from the CYP&S committee in September 2017 a 7 week public consultation was held between 2 October 2017 and 19 November 2017. The Council's Have your Say consultation portal hosted an online response form and 13 public meetings were also held during the consultation period.
- 5.2 In total 907 responses were received online, informal minutes of the public meetings were recorded and any feedback forms left were collected and analysed.
- 5.3 The Council promoted the public consultation and all of the city's maintained schools were asked to make parents aware of the consultation through their usual parent communication channels.

#### 6. CONCLUSION

- 6.1 Prior to the consultation the most up to date data available indicated that 126 pupils would not be able to be accommodated in their catchment area school(s) in September 2019. In 2020 it was forecast that 138 pupils would not be accommodated in their catchment area.
- In order to alleviate the issue of catchment areas failing to catch in the 2019 and 2020 admission rounds the council proposed to review catchment areas. It was hoped that this would reduce the uncertainties experienced by parents as a result of the random allocation tie-break procedure.
- 6.3 Since the consultation was launched the PAN of Blatchington Mill has been determined permanently at 330 pupils, 30 pupils more than originally accounted for and it is recommended that the Patcham High School PAN is raised by 10 pupils.
- 6.4 New pupil number projections using updated information only available after the time period of consultation afforded under the statutory guidance (School Admission Code) indicate that the number of pupils not able to be offered their

- catchment school in 2019 (having taken account of the rise in the PANs outlined above) is forecast to be 69 pupils. In 2020 it is forecast to be 93. Therefore the estimates have significantly reduced.
- 6.5 When this is coupled with the offer of Dorothy Stringer High School and Varndean School to admit temporarily an additional 60 pupils, in total, in 2019 and 2020 there no longer remains a compelling reason to change catchment areas. However by making no change there will still be some uncertainty experienced by parents where there are catchment areas with more pupils than places available.
- Whilst pupil forecasting is not an exact science, the methodology used to predict pupil numbers has shown significant accuracy in relation to admission is 2018. The Council estimated the need for 2,520 places and 2,527 applications have been received. It is the change in source data that has generated revised pupil numbers.
- 6.7 In relation to primary school PANs, the range and extent of responses against the proposals to reduce the PAN of Benfield Primary and Hertford Infant schools together with the lack of support from the governing body of each school informed the decision not to continue with the recommendation to reduce their PANs by one form of entry each.
- 6.8 It is therefore proposed to make no changes to existing school admission arrangements, with the exception of the revised PANs for those schools set out in recommendations 2.1-2.3, 2.6 and 2.7 to this report. The Council will continue to consider organisational changes that will address the surplus of primary school places forecast for the foreseeable future.

#### 7. FINANCIAL & OTHER IMPLICATIONS:

#### **Financial Implications:**

- 7.1 Schools are funded via a local authority formula, which is largely based on pupil numbers (based on their October census for the following financial year) and other elements for deprivation, attainment, lump sum and other premises allocations. School admission arrangements will directly effect the number of pupils each school will have, at each October census, and this will therefore effect the overall budget available to them.
- 7.2 For those schools that are expanding their PAN, growth funding will be set aside in the schools block of the DSG, to help them plan for the additional pupil increase in the financial year. The additional pupils will lead to an increase in budget share as well as additional costs for new teachers etc. For those three schools whose PAN will fall, they will have time to plan for the reduction in budget and associated reduction in costs. Each individual school will need to plan their budget based on the funding available to them in the relevant financial year.

#### Legal Implications:

- 7.3 Section 88C of the School Standards and Framework Act 1998, as amended by the Education and Skills Act 2008, requires admission authorities to determine their school admission arrangements by 28 February of the school year ('the determination year') immediately before the year when school places are offered. Where changes are proposed the admission authority must first publicly consult on those arrangements. Consultation must be for a minimum of 6 weeks and take place between 1 October and 31 January in the determination year.
- 7.4 Regulation 17(2)(c) of the 2012 Regulations requires admission authorities to determine their admission arrangements on or before 28 February in the determination year. The Council is also required to formulate and consult on a scheme for co-ordinating admission arrangements for all maintained schools within its area each academic year.
- 7.5 Admission arrangements must conform to the School Admissions Code which sets out acceptable and unacceptable admission arrangements and priorities. Any person or body who considers admission arrangements for either maintained schools or an Academy to be unlawful or contrary to the provisions of the Admissions Code may make an objection to the Schools Adjudicator. Any objections must be made by 15 May.
- 7.6 The Council, as admissions authority for maintained community schools, is able to agree to the admission of pupils above the published admission number on a temporary basis, i.e. a 'bulge class'. Such admissions do not constitute a permanent increase in the published admission number of a school.
- 7.7 Local Authorities have a statutory duty to ensure that there are sufficient primary and secondary schools to provide suitable education to meet the needs of the population in its area (Section 14 Education Act 1996).
- 7.8 If the committee recommends no change to the current catchment areas for secondary schools there will be no need for the admission arrangements to be referred to Full Council for decision. CYPS committee has the authority to determine any changes to Published Admission Numbers of schools without reference to Full Council.

#### **Equalities Implications:**

7.9 Planning and consultation for school admissions procedures and school places and the operation of the admission process are conducted in such a way as to avoid potentially discriminating admission priorities or planning processes. The city council and own admission authority school's governing bodies must be mindful of bad practice with regard to equalities issues as described in the School Admissions Code.

- 7.10 Making no change to catchment areas and reducing the number of pupils likely to not receive a place in their catchment area school means a formal EIA is not appropriate.
- 7.11 Changes to the Primary PANs are being proposed at three schools who have not been oversubscribed and where it is not anticipated that pupils will be without a place in one of their three preferred schools, or not be in receipt of a reasonable offer of a school place from the Local Authority. Therefore a formal EIA is not appropriate.

#### Sustainability Implications:

- 7.12 School admission arrangements are intended so far as it is possible to provide pupils with local places where they have asked for them. The planning of school places for the city takes into account the changing population pattern and resultant demand for places. The current pattern of parental preference is reflected in different schools operating both over and under capacity. In planning for school places the council will have regard to sustainability priorities and seek to provide local places and places which are accessible by safe walking and where possible cycling routes and public transport wherever this is possible.
- 7.13 Making no change to catchment areas and reducing the number of pupils likely to not receive a place in their catchment area school means there is a reduced sustainability impact than had been anticipated.
- 7.14 Reducing the PAN of three primary schools is not anticipated to create any sustainability impacts or implications.

This feeds into the capital programme so that resources are allocated where they will have the most beneficial effect.

#### Corporate / Citywide Implications:

1.4 The allocation of school places affects all families in all parts of the city and can influence where people choose to live. Failure to obtain the desired choice of school can create a strong sense of grievance. The process of expressing a preference and if disappointed, entering an appeal can create intense anxiety for many families in the city. Admission arrangements together with school place planning are framed in such a way as to be mindful of supporting the needs of communities.

## **Admission Arrangements for Secondary Schools**

The Council uses a catchment area system with random allocation being used as the tie breaker in each admission priority in the event of oversubscription. These arrangements are also used by Brighton Aldridge Community Academy (BACA) and Portslade Aldridge Community Academy (PACA). Cardinal Newman Catholic School and King's School have their own admission priorities (please visit <a href="https://www.brighton-hove.gov.uk/schooladmissions">www.brighton-hove.gov.uk/schooladmissions</a> for details).

The over subscription priorities are applied in the context of an equal preference system as required by the School Admissions Code. They are:

- 1. Children in the care of a local authority (looked after children), and children who were looked after but ceased to be so because they were adopted (or became subject to a residence order or special guardianship order).
- 2. Compelling medical or other exceptional reasons for attending the school.
- 3. A sibling link applied for those living within the designated catchment area only.
- 4. Those pupils living in the designated catchment area for the school(s).
- 5. Other children.

Within all these priorities, the tie break is random allocation.

The current catchment areas are set out in the attached catchment area map. It also includes information about which post codes are in each of the catchment areas.


## Admissions Arrangements for Community Infant, Junior and Primary Schools

The over subscription priorities are applied in the context of an equal preference system as required by the Admissions Code. They are:

- 1. Children in the care of a local authority (looked after children), and children who were looked after but ceased to be so because they were adopted (or became subject to a residence order or special guardianship order).
- 2. Compelling medical or other exceptional reasons for attending the school.
- 3. The sibling link.
- 4. For junior schools only: children attending a linked infant school
- 5. Home to school distance (measured by the shortest available route).

Within all these priorities, the tie break is home to school distance (measured by the shortest available route).

Scheme for co-ordinated admissions to secondary schools – Admissions Year 2019/20 (Admissions to year 7 in September 2019)

#### Introduction

The main purpose of the co-ordinated scheme is to ensure that every parent of a child living in Brighton & Hove who has completed a school preference form receives one offer of a secondary school place at the conclusion of the normal admission round for pupils transferring from primary to secondary school. The scheme is designed to foster clear communications on school admissions between the City Council, community schools, Academies (for the purposes of this document Free Schools are included as Academies), Cardinal Newman School, which as a voluntary aided secondary school acts as its own admission authority, and neighbouring Local Authorities (LAs) and admission authorities. It fulfils the requirements of the School Admissions (Admission Arrangements and Co ordination of Admission Arrangements (England)) Regulations 2012 and more detailed arrangements set out in the School Admissions Code 2014.

The scheme does not affect the rights of the different admission authorities mentioned to set their own admission priorities, and consider applications on the basis of those priorities. It is intended to set out a process and time scale for the exchange of pupil information between the parties to the scheme, resulting in the offer of a single school place. This should represent a preference listed by the parent/carer that it is possible to meet following the application of the admission priorities by this LA or by other admission authorities. Where it is not possible to allocate a place at any of the preferred schools for a child living in Brighton & Hove, a place will be offered at the nearest school to their home address within the city boundaries with a place available. This will not preclude parents from seeking an alternative place elsewhere if they are unhappy with the offer, nor will it prevent them from lodging an appeal with the admission authority for their preferred school.

All residents of Brighton & Hove should apply using the City Council's common application form (online or paper) even if they are seeking a place at a maintained school in the area of another Council.

The time scales set out in the scheme work towards the prescribed date (1<sup>st</sup> March or the first working day following 1<sup>st</sup> March where it falls at a weekend) on which secondary school place decisions must be notified to parents/carers. It will also be broadly in line with the time scales used by neighbouring LAs.

#### Process and detailed time scale

- 1. The school admissions leaflet published by the City Council will be distributed to parents at the beginning of September 2018. This LA will have identified those pupils entering Year 6 in city maintained schools (the transfer cohort) from primary school records. Neighbouring LAs will be asked to provide records of Brighton & Hove children attending schools in their areas so that admission leaflets can be sent to their parents/carers. Brighton & Hove will in return provide information to other LAs about their residents attending Brighton & Hove schools.
- 2. Parents/carers will be invited to list 3 preferences for a school place ranked in order of priority. These may be at a City Community School, an Academy, a Free School or a voluntary aided secondary school, or any maintained school outside the City of Brighton & Hove. Those residents in the City must use the Brighton & Hove school admission preference form to indicate their preferred schools, either the paper or online form. No other form of application will be valid. The LA allocates places on the basis of equal preference, and each preference listed will be prioritised in accordance with the published admission priorities for community and own admission authority secondary schools in the City. If it is possible to offer more than one place on the basis of those priorities, the one ranked higher on the preference form will be offered.
- 3. Parents and carers are strongly advised to apply online through the facility available on the Brighton & Hove City Council website. This will provide them with a response which confirms their preference listing and acts as proof of application. Alternatively the paper form should be completed and returned to the child's primary or junior school in the City, or to the Admissions Team at Hove Town Hall by 31 October 2018. Applicants for Cardinal Newman and/or King's School will need to return their supporting information directly to the school as well as submitting an online application or paper form to the Council. If supporting information is returned to the Local Authority, the documents will be shared with the school.
- 4. Where as part of its admission priorities a voluntary aided school, free school or academy within the City or beyond requires additional supporting

information, such as a Supplementary Information form, or proof of denominational commitment, that form or proof should be completed and returned by the same closing date. This is to ensure that target dates for the exchange of pupil information between authorities and the notification date for parents/carers can be met. Provided the LA common application form has been completed and returned, that additional information may be given direct to the school, or handed in with the preference form. Parents/carers will be advised through the admissions booklet of Brighton & Hove or neighbouring LAs, or through school published parent information, of any such additional information requirements for own admission authority schools.

5. If using an application form rather than online application parents and carers whose children attend maintained primary schools in the City are strongly advised to return the form via the school. Parents who prefer to post the form should understand that proof of posting is not proof of receipt, and they will not have confirmation of receipt in the same way as those applying online or returning the form to their child's school. All maintained junior and primary schools in the city will return secondary preference forms they receive to the LA in batches as they are received, with the final batch as soon as possible after the closing date. Schools should maintain a list to record the date on which each form was received, the school preferences, and if required will provide proof of receipt to the parent/carer. This ensures that on time applications and late applications are clearly recorded as such. It also provides assurance for parents should the school or the LA subsequently mislay the form.

#### No later than 21 November 2018.

- LA will identify the number of preferences (first, second or subsequent) received for each school.
- ❖ Cardinal Newman School and King's School will be provided with details of any parental preference where it gives the school as a preference (first, second or subsequent) received by the LA. It will apply its oversubscription criteria to prioritise all preferences. Where pupils have a Statement of Special Educational Needs or Education Health & Care Plan naming the school and must be offered a place this will be indicated. (These pupils must be given a place at the school in accordance with the SEN and Admissions Codes of Practice.)
- West and East Sussex and other LA's as necessary will be forwarded the details of preferences expressed for their schools by Brighton & Hove parents/carers (first, second and subsequent). Where the pupil has a Statement of Special Educational Needs or an Education, Health & Care Plan this will be indicated.
- West and East Sussex will be asked to provide a list of pupils living in those areas who have expressed a preference for a Brighton & Hove school (first, second or subsequent).

#### No later than 19 December 2018

Cardinal Newman School and King's School will provide the LA with a list showing children in priority order for places at the school. The list

- will show which admission criterion was applied to each child. The school will advise the LA of such additional information as is necessary to inform parents of the reason for its decision when allocation letters and emails are sent on 1 March 2019.
- Brighton & Hove will apply its admission priorities to all preferences received for community schools, and where the children are resident in other LAs, will inform that LA.

### Between 28 January and 8 February 2019

- Brighton & Hove will establish whether more than one offer could be made on the basis of the application of its own admission priorities and those of voluntary aided schools, free schools/Academies and other LAs. It will determine in each case which is the highest parental ranking.
- Final lists of school allocations will be prepared.
- ❖ Emails and letters to parents/carers will be prepared.
- Consideration will be given to late applications received before 22 January, as set out in Appendix A below.
- Neighbouring LAs will be sent final details of children living in their area offered a place at a Brighton & Hove school, and for whom they will need to send allocation letters.

#### 1 March 2019

Online applicants will receive their decisions by e-mail. Letters will be sent to parents/carers who have not applied online or who have specifically requested this. The LA email or letter to parents will contain the following:

- If they have not been allocated a school of preference, the reason why not
- How places at all Brighton & Hove schools were allocated.
- Where it is an own admission authority school, the fact that the offer is made on behalf of the governing body of the school.
- Where it is a school maintained by another LA, the fact that the offer is made on behalf of that LA.
- The right of appeal to an independent panel, and how to arrange an appeal for a community school, a voluntary aided school, and in the case of schools in other LA's, who to contact.
- Details about waiting lists and reallocation pools for preferences that could not be met.

#### 1 April 2019

Parents and carers should accept offers of places by this date in order to allow schools and the LA ample planning time for the new intake. This does not affect their right to appeal if the place they are accepting is not their highest preference. Parents should also have exercised their right to appeal by this date if they want to be assured of having their appeal heard in the main round of appeals.

#### **Proof of address**

The LA may require parents/carers to provide proof of address if they apply for a place at a community school. Own admission authority schools may also request proof of address from their applicants.

## Appendix A – Changes of address and late applications

#### New arrivals in the city

Parents/carers moving into the City in the course of the admission process who are making an application on the basis of their new address must provide evidence of either a tenancy agreement of six months or more or an exchange of contracts if they are purchasing a property. Applicants should return their preference form by the closing date if possible, especially if their move took place before the closing date, forwarding proof of the move at the earliest opportunity. If they provide the form and the evidence of the move by 22 January 2019 their application will be included in the main admissions round.

### Late applications received before the 22 January 2019.

- I. With the exception of families moving into the area and cases as described at V below, forms received after the closing date will not be considered by the LA until school allocations have been made for those received by the closing date. Any received for Cardinal Newman School and/or King's School will be forwarded to the school, which will decide whether or not to include the application in the main admission round.
- II. Any preference forms for community schools received in respect of children in care will be included in the main admission round as valid first preferences at any time up to the allocation date on **8 February 2019**. Where such applications are received after that date, the LA will, if attendance at that school is seen as a necessity for the welfare of the child, seek to offer places at the school of first preference, if necessary negotiating with that school to admit beyond the published admission number in order to do so. If, however, it is acceptable to offer a place at a lower ranked school without going over numbers, the LA will discuss that possibility with the social worker for the child. Applications for Cardinal Newman School, King's School or schools in other LA areas for children in care will be considered in line with the admission arrangements for those schools and the requirements of the Admissions Code.
- III. Applications received after the closing date but before the 22 January 2019 will be sent a letter allocating a school place on 1 March 2019 or as soon as possible after that date if the volume of late applications is high. Applications received after this date will be sent an allocation letter as soon as possible after 1 March 2019.
- IV. Parents/carers living in the City who change a preference as a result of a change of address within the city, and who return the new form and evidence of the address change will have that change considered in the main round of allocations if it is received by 22 January 2019. They will have to provide evidence of the address change. Those applications received after that date will be considered as late applications.

V. Other late applications where there is good reason for the delay will be considered in the main round of allocations if received by 22 January 2019 where independent evidence is given by a third party (usually a professional source such a doctor or social worker) to support the reason for the delay.

## Late applications received after the 22 January 2019.

- I. Where an application is received after the allocation date, from a parent/carer living in the City, they must use the Brighton & Hove online application service or paper preference form. If the preference(s) is for a community school, the LA will allocate a place if the school remains under subscribed. If the school(s) is fully subscribed, a place will be allocated at the nearest school to the home address that has a vacancy. Brighton & Hove will seek to make a decision as soon as possible after receiving the application. Where a preference is given for a free school, an Academy, Cardinal Newman School or a school in a neighbouring LA, the form will be passed to that admission authority for a decision. They will be asked to reach a decision within fourteen days of receiving the form. Brighton & Hove will endeavour to send a decision to the parent /carer as soon as possible once it has either reached a decision, or been informed of a decision by the other admission authority.
- II. If a change of preference or preference order is received following the decision letter on 1 March 2019 and the home address has not changed (and there has been no other relevant change of circumstances), that changed preference will not be considered until after 30 June 2019. This allows reasonable time for the consideration of late first applications and the operation of the reallocation pool where places have been offered and refused.
- III. All applications received after the beginning of the autumn term will be regarded as outside the admission round. Nonetheless, Brighton & Hove will act as the point of contact for all preferences for parents/carers living in the City, and will liaise with Cardinal Newman School, King's School, BACA, PACA and other LAs over applications for admission to schools other than Brighton & Hove Community Schools. The Brighton & Hove online or paper form should be used in all cases by City residents and returned to the Brighton & Hove Admissions Team. The same arrangements will apply to applications for admission to schools for year groups other than the normal admission group in Year 7. Where the LA, Cardinal Newman School, King's School, BACA, PACA or another admission authority is not able to offer a place in accordance with a parental preference, the LA will offer a place at the nearest school to the home address of the applicant with a vacancy in the appropriate year group. This may be an Academy or a church VA school. Admissions to Years 12 and 13 in those schools that make such provision will be regarded as transfer admissions rather than admission at a normal point of entry. (The majority of such pupils will have attended the school from Year 7, or

transferred to the school in Key Stage 3 or 4.) Should any other schools adopt Academy status, this paragraph will also apply to them.

#### Re-allocation Pool

- I. Brighton & Hove will operate a re-allocation pool system for its community schools, BACA and PACA. (Cardinal Newman School and King's School will operate their own waiting list/reallocation arrangements.) The ranking within this system will be based on the Brighton & Hove admission criteria. All children will be automatically placed in the re-allocation pool for all un-met first preferences for community schools. Parents/carers will be asked to indicate if they also wish to be placed in the re-allocation pool for a different preferred school when the allocation emails and letters are sent on 1 March 2019. Places will be offered to children from the pool as soon as a place becomes available at an over subscribed school and the admission priorities have been applied. This LA will notify other LAs as appropriate if it offers a place from the pool at a Brighton & Hove school to a pupil living outside the City. The pool will operate until the end of the Autumn Term.
- II. Other admission authorities will operate a re-allocation or waiting list system. If they are able to place a child resident in Brighton & Hove in one of their schools they are asked to notify this LA at the earliest opportunity.
- III. Parents/carers wishing to keep their child's name in the reallocation pool beyond the end of the Autumn Term must inform the LA. They must renew the position on the reallocation pool each term thereafter. Applicants outside of the main admission exercise will be placed in the reallocation pool for one term, and must ask for the child's name to remain on the waiting list each term thereafter.

#### **School Admission Appeals**

- I. Parents/carers wishing to appeal against the LA's or a voluntary aided school's decision not to offer a place at a preferred school should do so in writing or using the online appeal facility by 1 April 2019 if they want to be assured of having their appeal heard in the main appeal round.
- II. The LA will not arrange an appeal, or ask an own admission authority school to arrange an appeal for a school that was not included on the original application. It will only arrange an appeal for a school that was listed as a preference, as it will not have given a decision to the parent/carer for schools not included on the form. If a parent/carer wishes to receive a decision for a school not included in their original preference, and thus acquire a right of appeal, they must complete a further application. However, unless there is a change of address or other change of circumstances leading to the change of preference this new form will not be considered until after 30 June 2019.
- III. Parents/carers will receive 10 school days notice of the date of the appeal hearing, and will receive copies of any documentation relating to the appeal 7 days in advance of the hearing.

- IV. Whilst the City Council, other LAs and the Governing Bodies of Academies and voluntary aided schools will make every effort to hear appeals within 40 school days of the deadline for submitting appeals, as suggested in the Appeals Code, they cannot guarantee this time scale. The volume of appeals to be heard and the availability of the appeal panel members, who are volunteers, will have a direct affect on the timing of the appeal hearings.
- V. Appeals for late applications and school transfers outside the normal admission round will be arranged as soon as practicable after the decision to refuse a preference has been conveyed to the parent/carer or if appropriate to the student, and in any case within 30 school days of the appeal being lodged.
- VI. Appeals will be heard for refusals to places in Years 12 and 13 on the basis that they are school transfers.

#### **BRIGHTON & HOVE CITY COUNCIL**

Scheme for co-ordinated admissions to infant, primary and junior schools – Admissions Year 2019/20 (Admissions to Reception or year 3 of Junior School in September 2019)

#### Introduction

The main purpose of the co-ordinated scheme is to ensure that every parent of a child living in Brighton & Hove who has completed a school preference form receives one offer of an infant, primary or junior school place. This will be on a set date following the conclusion of the normal admission round for pupils seeking admission to school. The scheme is designed to foster clear communications on school admissions between the City Council, community schools, Academies (for the purposes of this document Free Schools are included as Academies), and voluntary aided schools which act as their own admission authority, and neighbouring Local Authorities (LAs) and admission authorities. It fulfils the requirements of the School Admissions (Admission Arrangements and Co-ordination of Admission Arrangements (England)) Regulations 2012 and more detailed arrangements set out in the School Admissions Code 2014.

The scheme does not affect the rights of voluntary aided schools and Academies to set their own admission priorities, and consider applications on the basis of those priorities. It is intended to set out a process and time scale for the exchange of pupil information between the parties to the scheme, resulting in the offer of a single school place. This should represent a preference listed by the parent /carer following the application of the admission priorities by the Local Authority (LA) or by own admission authority schools. Where it is not possible to allocate a place at any of the preferred schools for a child living in Brighton & Hove, a place will be offered at the nearest school to their home address within the city boundaries with a place available. This will not preclude parents from seeking an alternative place elsewhere if they are unhappy with the offer, nor will it prevent them from lodging an appeal with the admission authority for their preferred school.

All residents of Brighton & Hove should apply using the City Council's common application form (online or paper) even if they are seeking a place at a maintained school in the area of another Council.

The time scales set out in the scheme will be broadly in line with the time scales used by neighbouring LAs. Please be aware that governing bodies for VA schools and Academies will need to meet between 15 February 2019 and 08 March 2019 when the ranking order needs to be returned to the Local Authority.

## Process and detailed time scale – infant, junior and primary schools

- 1. The school admissions booklet published by the City Council will be distributed on request to parents/carers applying for infant or primary school places. A publicity campaign will be launched in September 2018 encouraging parents to apply online. Leaflets and posters will be sent to schools, other council services, early years settings, the press and other media to parents of those pupils seeking places in school. Schools will be asked to act as a collection point for information about pupils seeking school places.
- 2. Parents/carers will be invited to list 3 preferences for a school place ranked in order of priority. These may be at a City Community School, an Academy, a Free School or a voluntary aided school, or any maintained school outside the City of Brighton & Hove. Those residents in the City must use the Brighton & Hove school admission preference form to indicate their preferred schools, either the paper or online form. No other form of application will be valid. The LA allocates places on the basis of equal preferences, and each preference listed will be prioritised on the basis of the published admission priorities for community and own admission authority schools. If it is possible to offer more than one place on the basis of those priorities, the one ranked higher on the preference form will be offered.
- 3. Parents and carers are strongly advised to apply online through the facility available on the Brighton & Hove City Council website. This will provide them with a response which confirms their preference listing and acts as proof of application. Alternatively the paper form should be completed and returned to their local infant/primary school or to the Admissions Team at Hove Town Hall, Hove by 15 January 2019.
- 4. Where as part of its admission priorities a voluntary aided school requires additional supporting information, such as a Supplementary Information form, or proof of denominational commitment, that form or proof should be completed and returned by the same closing date. This is to ensure that target dates for the exchange of pupil information and the notification date

for parents/carers can be met. Provided the LA preference form has been completed and returned, that additional information may be given direct to the school, or handed in with the preference form. Parents/carers will be advised through the admissions booklet for Brighton & Hove, and through school published information, of any such additional information requirements for voluntary aided schools. Parents/carers with queries about voluntary aided school admission requirements should contact the school for further information.

5. If using an application form rather than online application parents and carers are strongly advised to send their form via a preferred school. Parents who post the form should understand that proof of posting is not proof of receipt, and they will not have confirmation in the same way as those applying online or returning the form to a school. All maintained infant and primary schools in the city will return preference forms to the LA in batches as they are received, with the final batch as soon as possible after the closing date. Schools should maintain a record of the date on which each form was received, and if required will provide proof of receipt to the parent/carer. This ensures that on time applications and late applications are clearly recorded as such. It also provides assurance for parents should the school or the LA subsequently mislay the form.

## 6. No later than 15 February 2019

- ❖ LA will identify the numbers of preferences (first, second and third) received for each school.
- ❖ Voluntary aided schools, free schools and academies will be provided with details of parental preferences where their school is given as a preference. They will apply oversubscription criteria to prioritise all preferences. Where pupils have a Statement of Special Educational Needs or Education, Health & Care Plan (naming the school) and must be offered a place this will be indicated. These pupils must be given a place at the school in accordance with the SEN and Admissions Code. This applies to all maintained schools, including Voluntary Aided.
- West and East Sussex and other LA's as necessary will be forwarded the details of preferences expressed for their schools by Brighton & Hove parents/carers (first, second and third). Where the pupil has a Statement of Special Educational Needs or Education, Health & Care Plan this will be indicated.
- West and East Sussex will be asked to provide a list of pupils living in those areas who have expressed a preference for a Brighton & Hove school (first, second or subsequent).

#### 7. No later than 8 March 2019

❖ Voluntary aided schools, free schools and academies will provide the LA with a list showing children in priority order for places at the school. The list will show which oversubscription criterion was applied to each child, and relevant information to apply any necessary tie-break. The school will advise the LA of such additional information as is necessary

- to inform parents of the reason for its decision when allocation letters are sent on 16 April 2019.
- Other LAs will provide Brighton & Hove LA with a list of which Brighton & Hove pupils could be offered places in their schools. They will advise Brighton & Hove of the reason where a preference cannot be met for inclusion in the allocation letters on 16 April 2019.
- Brighton & Hove will apply its admission priorities to all preferences received for community schools, and where the children are resident in other LAs, will inform that LA.

### 8. No later than 5 April 2019

- Brighton & Hove will establish whether more than one offer could be made on the basis of the application of its own admission priorities and those of voluntary aided schools, free schools, academies and other LAs. It will determine in each case which is the highest parental ranking.
- Final lists of school allocations will be prepared.
- Emails to parents/carers will be prepared.
- Consideration will be given to qualifying late applications received before 8 March 2019.
- Discussions will take place with other admission authorities as necessary to resolve any remaining unallocated applications.
- Neighbouring LAs will be sent final details of children living in their area offered a place at a Brighton & Hove school, and for whom they will need to send allocation letters.

#### 9. 16 April 2019

Online applicants will receive their decisions by e-mail. Letters will be sent to parents/carers who did not apply on line. The LA email or letter to parents will contain the following:

- If they have not been allocated a school of preference, the reason why not.
- How places at the preferred schools were allocated.
- The right of appeal to an independent panel, and how to arrange an appeal for a community school or a voluntary aided school.
- Details about waiting lists for preferences that could not be met.

## 10. 22 May 2019

Parents and carers should accept offers of places by this date in order to allow schools and the LA ample planning time for the new intake. This does not affect their right to appeal if the place they are accepting is not their highest preference. Parents should have also exercised their right to appeal by this date if they want to be assured of having their appeal heard in the main round of appeals.

#### 11. Proof of address

The LA may require parents/carers to provide proof of address if they are applying for a community school place. Own admission authority schools may also request proof of address from their applicants.

## Appendix A – Changes of address and late applications

### New arrivals in the city

Parents/carers moving into the City in the course of the admission process who are making an application on the basis of their new address must provide evidence of either a tenancy agreement of six months or more or an exchange of contracts if they are purchasing a property. Applicants should submit their application by the closing date if possible, especially if their move took place before the closing date, forwarding proof of the move at the earliest opportunity. If they provide the form and the evidence of the move by 8 March 2019 their application will be included in the main admission round.

## Late applications received before the allocation date

- I. With the exception of families moving into the area and cases as described at V below, forms received after the closing date will not be considered by the LA until allocations have been made for those received before the closing date. Any received for an own admission authority school will be forwarded to the school. The school will decide whether or not there is a good reason to include these late applications in the main admission round, but will only consider them if they are received before 8 March 2019.
- II. Any preference forms received for community schools in respect of children in care will be included in the main admission round as valid preference at any time up to **5 April 2019**. Where such applications are received after that date, the LA will, if attendance at that school is seen as a necessity for the welfare of the child, seek to offer places at the school ranked highest on the preference form. If, however, it is acceptable to offer a place at a lower ranked school without going over numbers, the LA will discuss that possibility with the social worker for the child. Applications to voluntary aided schools, free schools and academies received on behalf of children in public care will be considered in line with the published admission policy for each school and the requirements of the School Admission Code.
- III. Applications received after the closing date but before the 8 March 2019 will be sent a letter allocating a school place on 16 April 2019 or as soon as possible after that date if the volume of late applications is high. Applications received after this date will be sent an allocation letter as soon as possible after 16 April 2019.
- IV. Applications received after the closing date will be sent a letter allocating a school place as soon as possible after the main notification date of 16 April 2019.
- V.
   VI. Parents/carers living in the City who change any preference as a result of a change of address, and who return the new form by 8 March 2019 will have that change considered in the main round of allocations. They will have to provide evidence of their new address and will not have their changed application accepted without that evidence.

VII. Other late applications where there is a good reason for this will be considered in the main round of allocations if received by 8 March 2019 where independent evidence is given by a third party (usually a professional source such as a doctor or social worker) to support the reason for the delay.

## Applications received after the allocation date

- 1. Where an application is received after the allocation date, from a parent/carer living in the City, they must use a Brighton & Hove preference form. If the preference(s) is for a community school, the LA will allocate a place if the school remains under subscribed. If the school(s) is fully subscribed, a place will be allocated at the nearest school to the home address that has a vacancy. Brighton & Hove will seek to make a decision as soon as possible after receiving the form. Where a preference is given for an own admission authority school or a school in a neighbouring LA, the form will be passed to that admission authority for a decision. They will be asked to reach a decision within fourteen days of receiving the form. Brighton & Hove will endeavour to send a decision to the parent /carer either as soon as possible once it has reached a decision, or has been informed of a decision by the other admission authority.
- 11. If a change of preference or preference order is received following the decision letter on 16 April 2019 and the home address has not changed, that changed preference will not be considered until after 30 June 2019. This allows reasonable time for the consideration of late first applications and the operation of the waiting list where places have been offered and refused.
- All applications received after the beginning of the autumn term 2019 will be regarded as outside the admission round. Nonetheless, the LA will act as the point of contact for all preferences from parents/carers living in the City. The LA will liaise with own admission authority schools over applications for admission to those schools, and will inform parents of their admission decisions, if necessary allocating an alternative school place. The LA online or paper preference form should be used in all cases. The same arrangements will apply to applications for admission to schools for year groups other than the normal Reception year. (See also co-ordinated scheme for in-year applications.) This ensures that the LA has a full record of pupil admissions, and supports both the schools and the LA in their responsibilities for pupil tracking and safety.

## **Waiting List**

I. Brighton & Hove will operate a waiting list system for its community schools. (Own admission authority schools make their own waiting list arrangements). The waiting list ranking will be based on the LA admission criteria. Rankings within each priority will be determined by home to school distance. All children will be automatically placed on

- the waiting list for the community school for which they have expressed a first preference, although parents will be given the option of also asking to go on the waiting list for a different preferred school when places are allocated on **16 April 2019**. Places will be offered to children from the waiting list as soon as a place becomes available at an over subscribed school and the admission criteria have been applied. The waiting list will operate until the end of the Autumn Term.
- II. Parents/carers wishing to keep their child's name on the list for longer than the end of the Autumn Term must inform the LA. They must renew the waiting list place each term thereafter. Applicants outside of the main admission exercise will be placed on waiting lists for one term, and must ask for the child's name to remain on the waiting list each term thereafter.

## **School Admission Appeals**

- I. Parents/carers wishing to appeal against the LA's decision not to offer a place at a preferred school should do so by **22 May 2019** if they want to be assured of having their appeal heard in the main appeal round.
- II. The LA will not arrange an appeal or ask a voluntary aided school to arrange an appeal for a school that was not included on the original application. It will only arrange an appeal for a school which was listed as a preference, as it will not have given a decision to the parent/carer for schools not included on the form. If a parent/carer wishes to receive a decision for a school not included in their original application, and thus acquire a right of appeal, they must complete a further application. However, unless there is a good reason for a change of preference this new form will not be considered until after 30 June 2019.
- III. Parents/carers will receive 10 school days notice of the date of the appeal hearing, and will receive copies of any documentation relating to the appeal 7 days in advance of the hearing.
- IV. Appeals for on-time applications much be heard within 40 school days of the closing date for appeals to be lodged. The volume of appeals to be heard and the availability of the appeal panel members, who are volunteers, will have a direct affect on the timing of the appeal hearings.
- V. Appeals for late applications and school transfers outside the normal admission round will be arranged as soon as practicable after the decision to refuse a preference has been conveyed to the pupil and the parent/carer, and in any case within 30 school days.

# Scheme for co-ordinated admissions In Year allocations – Admissions Year 2018/19

#### Introduction

The requirement for In-Year co-ordination was abolished by the School Admissions Code 2012, however there is still a requirement for the LA to retain a monitoring role in in-year allocation of school places. In view of this it is proposed to continue to retain in-year co-ordination between maintained schools in Brighton & Hove. The co-ordination referred to in this document will be offered to schools free of charge. However, it may be possible for own admission authority schools to purchase additional services should they wish to do so.

This scheme for in-year admissions will come into force from 1 September 2018.

#### **Procedure**

- 1. Parents may name up to three preferences on the Brighton & Hove application and all preferences expressed by parents will be treated equally. This means that each preference will be measured against the published oversubscription criteria only, without reference to the order stated by the parent. Only one school place will be offered, and this will be the highest possible preference expressed by the parent that can be agreed.
- 2. Where it is not possible to offer any of the named preferences, the applicant will be advised to remain at their current school if possible, or an alternative school place within Brighton & Hove will be offered. This will normally be the nearest school appropriate to the child's age and educational needs with a place available.
- 3. In order for parents to make a valid application for a maintained school place in Brighton & Hove, parents must complete a common application form provided by Brighton & Hove City Council. The Brighton & Hove application form will be available in paper form or can be accessed directly online or as a download from the Brighton & Hove City Council website.
- 4. Schools where the governing body is the admission authority may require additional information in order to apply their oversubscription criteria and in the case of church voluntary aided schools will provide a supplementary information form to the parent. Where the parent fails to complete the supplementary form, the governing body will rank the application according to the information given on the application form only. Where the parent completes the supplementary form but fails to complete the application form, this will not constitute a valid application.
- 5. Completed supplementary information forms will be returned to the individual schools, and not the School Admissions Team.

Preferences for own admission authority schools.

- 1. Where the parent names an own admission authority school in Brighton & Hove (ie a Voluntary Aided school, a Free school or an Academy), the child's details, (i.e. name, address, date of birth and any supporting documents) will be sent to the governing body. They will rank the preferences according to their published admission criteria and confirm with the City Council, no later than **five school days** after receipt of the form, whether it would be possible to offer a place. Should any other schools become Academies before or during the 2018/19 academic year, this paragraph will also apply to them.
- 2 Any applications submitted by parents/carers to schools in error must be forwarded to the City Council admissions team.
- 3 Brighton & Hove admissions authority acting for BACA, PACA and City Academy Whitehawk will rank admissions priorities as these Academies are at the present time retaining the same arrangements as other Brighton & Hove Community Schools.

## Notifying parents of the outcome of their applications.

- 1. The City Council will notify parents of the outcome of their applications. This is regardless of whether the City Council is the admission authority. This will be done by email or letter as appropriate, and will advise parents to contact the allocated school to arrange a mutually convenient start date.
- 2. Parents are expected to confirm acceptance of the offer of a school within fourteen days after the date of the offer.

## Postdated Applications and changes of address

- 1. Parents who apply for a school place for a date which is more than half a school term in the future will be sent a holding letter explaining that their application will not be processed until the half term before the date the place is required. Their application will be considered along with any others which are outstanding at that point.
- 2. Parents who are moving into, or within, Brighton & Hove, may apply at any time during the moving process. However, their application will not be processed until the City Council has received proof of the new address (e.g. evidence of exchange of contracts or a copy of a signed tenancy agreement). This allows the Council to apply the appropriate priority for admission based on the new address.

## **Appeals**

- 1. Parents will be informed of their statutory right of appeal when they receive the outcome of their applications. Parents can appeal for any preference expressed but not allocated, even if it was a lower preference than the one offered.
- 2. Appeal forms for Brighton & Hove schools will not automatically be sent with the notification letter, but are available on the council's website and hard copies are available on request.

## **Waiting lists**

- 1. Waiting lists for all Brighton & Hove community **primary** schools will be held by the City Council, but schools where the governing body is the admission authority will maintain their own waiting lists and advise on the ranking of these lists in accordance with their published oversubscription criteria.
- 2. All community school waiting lists or re-allocation pools will be cleared at the end of each term. Any parents wanting their child to remain on a waiting list or reallocation pool will need to contact the admission authority to request this on a termly basis.
- 3. There is no requirement to maintain waiting lists after the end of the Autumn term of the year of entry (ie Reception, year 3 or year 7). This being so, Brighton & Hove City Council proposes to close re-allocation pools for **secondary** schools in year 11. Other admission authorities may continue to maintain waiting lists.
