139	Hove Central Library 182 - 186 Church Road, Hove	BH2018/01123	The application <b>description</b> has been amended to: Alterations to rear garden area incorporating new steps, handrail and landing for use by children's day nursery.
161	Brighton Square And Units 12, 13, 14, 15 And 16 Brighton Square	BH2017/03651	Conservation Advisory Group Comment (not included within committee report):  The Group unanimously recommended REFUSAL.  The use of public spaces for private, commercial purposes on a permanent basis should not be permitted within the city as matter of principle. The Old Town in particular has very few open pedestrian-only spaces, the main ones being Bartholomew Square, Brighton Square, and the loosely defined square on the West side of East Street. Bartholomew Square has already been substantially lost to commercial encroachment following approval of the Moshimo Skylight restaurant and ground floor extensions. The permanent loss of substantial parts of two out of these three public spaces within a period of two years would be severely detrimental to the character of the Conservation Area.  The proposed structure is an inappropriate design out of character within the context of Brighton Square which is locally listed and received a Civic Trust Award in 1967. The Old Town Conservation Area has been classified by Historic England as "at risk", further emphasising the need for careful management of its conservation assets.  The Group is concerned that the proposed materials of timber and polycarbonate will not weather well and be vulnerable to vandalism and graffiti. If the officer decision is minded to approve then CAG request that that this application be sent for discussion at Planning Committee
