THE DECISION

- (1) That it be approved that City Older People and OPMH care home providers who are eligible for inclusion on the Preferred Provider Scheme be awarded a 3.5% increase. That it be approved that providers who do not qualify for inclusion on the Preferred Provider Scheme be awarded a 2.5% increase (see Appendices 1 and 2), subject to agreement of the 2009/10 budget package. The 2.5% increase constitutes the inflationary increase, whereas the additional 1% is for quality.
- (2) That an inflationary award of 2.5% is awarded to the following, subject to agreement of the 2009/10 budget package:
 - Those in Older People and OPMH care homes who do not qualify for inclusion in the Preferred Provider Scheme.
 - Out of City Older People and OPMH care homes.
 - Those care homes providing services for other categories of care where there are no set rates, excluding learning disability services.
 - Domiciliary care agencies providing services for all categories of care.
 - Direct Payment rates.

REASON FOR THE DECISION

Fairer Contracting, by paying a fair rate with a fair contract is intended to secure local care home provision for local Older People and OPMH.

At the same time it is intended to drive up quality and make savings for the Primary Care Trust through bringing Continuing Care fees more in line with the Council's fee rates.

DETAILS OF ANY ALTERNATIVE OPTIONS

Preferred Provider Schemes in use elsewhere in the Country were examined. Providers' comments on alternative Schemes were considered.

There is the opportunity to do nothing. If this were the case it is unlikely that providers would have the resources of the impetus to drive up quality to the standards needed locally. The current good relationships between purchasers and providers would be damaged and the costs of Continuing Healthcare would remain high.
