2. The content and presentation of the PIR is kept under constant review. Performance reports are presented by exception only. An alternative option would be to reduce the length of the PIR.
3. It is intended to publish a new Children and Young People's Plan in April 2009 and, as part of the review process, careful consideration will be given to ensuring the performance framework is fit for purpose and reflects the national policy to reduce the burden of reporting across the public sector.
