- 1) To withdraw the proposal to close the nursery by the end of April 2010 and, to reassure parents and staff that there will be no change to the status of the nursery before September 2011.
- 2) To increase the fees for the nursery from April 2011 in line with fees increases in other Council run nurseries in the city and to consider other measures to improve the sustainability of the nursery.
- 3) The development of a proposal for how the Bright Start nursery could be offered as a community assets in advance of the Localism legislation and to consult on this proposal before making a final decision about the future of Bright Start including the option of closure.

REASON FOR THE DECISION

The Leader of the Council's statement following the large number of representations she had received asking for the nursery to be kept open and from proposals in the Localism Bill introduced into Parliament on 13 December. The Bill aims to allow people to take charge of their lives by pushing power downwards and outwards to the lowest possible level, including individuals, neighbourhoods, professionals and communities. The Bill proposes that where services are enjoyed collectively, they should be delivered by accountable community groups
