- (2) That the Lead Commissioner be authorised to enter into the framework agreement with contractors following a compliant procurement process.
- (3) That the Lead Commissioner of Adult Social Care Delivery Unit be authorised to take all steps necessary or incidental to the implementation of recommendations 2.1. and 2.2 and including the awarding of the framework agreement.

REASON FOR THE DECISION

- (1) Ensure best value for minor adaptations works to the homes of disabled people, primarily in the owner occupied and privately rented sectors but also (to a lesser degree) in the public sector through competitive tendering process and economies of scale.
- (2) Ensure ongoing high quality of works through competitive framework with a range of contractors.
- (3) Ensure timely, efficient service in the provision of minor adaptations to Brighton and Hove City Council residents.

- (1) **Continue existing arrangement**: not recommended as this should only be a temporary arrangement and it is not protected by a formal agreement. As such it does not offer the benefits outlined above.

- (3) **Use of existing HAS Framework Agreement** terms of the current HAS contract do not extend to works in owner occupier or privately rented sectors.
