### Local demographics: Transport context

- Densely populated City
- 8.5 million visitors per year
- Over 100,000 vehicle trips in AM & PM peak hours
- 32,000 commuter journeys in/28,000 in = net export of 4,000
- Events
- Roadworks
- Air Quality
- 616 km public roads & 1100km of footways
- £1.4 billion worth of assets
- Value of maintenance backlog = £60m for roads & footways
- Transport central to :
  - Employment, Education, Shopping, Leisure, Recreation, Health

  - Brighton Centre and Churchill Square Area
  - Brighton Marina, Gas Works and Black Rock
  - Lewes Road Area

- Possible opportunities for Transport Committee contribution



## LTP3 - Strategic Transport Vision

"To deliver an integrated, accessible and balanced transport system that supports economic growth and enables people to travel around and access services as safely and freely as possible, while minimising damage to the environment and contributing to a safer, cleaner, quieter and healthier city."

## LTP3 - Transport Goals (Challenges)

- Support economic growth
- Reduce carbon emissions
- Promote equality of opportunity
- Contribute to better safety, security and health
- Improve quality of life and a healthy, natural environment



## **Recent Progress**

- Approval of LTP3 programme at Cabinet March 2012
- Managed delivery of £4.5m LTP capital programme 2011/12
- Better Bus Area: £3.48m awarded plus £1.2m match funding for Edward Street corridor
- Lewes Rd corridor: £4m awarded plus £2m partnership funding
- Upgrading RTI system to GPRS with £500,000 LSTF funding
- Old Shoreham Rd cycle lanes: £300,000 secured from SUSTRANS
- East Street/Old Town: A259 junction improvements
- Two pilot 20mph speed limit schemes
- 3Ts development: £0.5m secured for highways improvements



- LTP Capital Programme (2012/13 2014/15)
- Detailed 2012/13 programme presented to and agreed by Cabinet in March 2012
  - Indicative programmes up to 2014/15 also proposed and noted
  - Annual cycle of decisions on firmer detail of programmes will continue
  - Road and Pavement Maintenance = £4.2m
  - Streetlighting = £2.76m
  - Bridges and other structures = £2.58m
